### ***Liability Release***

I, \_\_\_\_\_, have read this entire document. By signing below, I agree that I have been given reasonable notice of the potential hazards of working on and visiting a farm. I understand that working on uneven terrain with exposure to unpredictable climatic conditions, wildlife, and other unforeseeable variables poses some inherent risk.

I understand that bees are kept on the farm property to pollinate crops and that it is my responsibility to bring with me any medical requirement (such as EpiPens) for myself or anyone else I bring with me to the farm if they are known to be allergic to bee stings or to have any other serious allergies. I certify that I am healthy enough for farm work and that I have no medical condition or restriction on my activities that conflicts with this commitment. If I am disabled, accommodation can be made for my condition. I understand that farm tools and equipment may also pose an inherent danger if not used properly and for the intended purpose, as I have been instructed. I understand that parking is only allowed in certain areas. Staff can show you where to park.

GENERAL RELEASE. Understanding all the above, I hereby release forever and discharge Down to Earth CSA, including all of its members, workers, and any other persons or entities not named here who might be liable or claimed to be liable, from any and all demands, liability, claims, damages, attorney fees, actions and suits, pertaining to damages, claims or injuries of any kind whatsoever to person or property that I or anyone accompanying me to the farm may now have or hereafter have arising from or related to my presence or activity while at the farm (109 Bradway Road, Stafford, CT 06076). I understand that any and all work that I perform while on the site is done so willingly, and it is my responsibility to work and act safely and ask for guidance when needed. By signing this General Release, I knowingly accept responsibility for informing anyone in my family/member group of these same risks, and that my signature is therefore binding for all members of my family/member group.
